### UC Health Appoints Richard P. Lofgren, MD, MPH, FACP President & CEO



Richard P. (Rick) Lofgren, MD, MPH, FACP, has been appointed president and CEO of UC Health. His appointment is effective today, Dec. 2. Lofgren is both a physician who is board-certified in internal medicine and a highly experienced health care administrator whose career spans 35 years. He succeeds James A. Kingsbury, who announced his retirement in May.

"I am truly honored to be appointed to this position and deeply appreciate the trust the board has placed in me," said Lofgren. "I look forward to working with the UC Health board, the UC Health executive team, the UC College of Medicine dean and chairs and the University as a whole to propel UC Health forward and position it as one of the nation's most preeminent providers."

Lofgren previously served at UK HealthCare (UKHC), the University of Kentucky's health system, and held two senior-level positions during his tenure there that

Transformed UKHC into a highly successful health system.

His first appointment at UKHC, made in 2004, was chief medical officer (CMO). As CMO, he was a member of the senior executive team that transformed UKHC into an integrated clinical enterprise and developed a growth strategy that saw the health system's market share grow from 28.5 percent to 43.3 percent and revenues grow from \$345 million to \$705 million during a five-year period. He also implemented several new quality and safety programs that reduced mortality to 30 percent lower than expected. Lofgren was then promoted in 2008 to vice president for health care operations and chief clinical officer with executive oversight of the operations of UKHC's clinical services, including its three hospitals, ambulatory services and faculty practices.

In this expanded role, Lofgren piloted UKHC to a new level of performance that led to significant growth across multiple hospital services over five years: he grew discharges by 23.6 percent; operating room cases by 33 percent; and emergency department visits by more than 66 percent. He also dramatically increased the number of inpatient and outpatient referrals to UKHC despite the serious economic downturn, driving 32 percent growth of inpatient transfers and 24 percent growth of new patient visits to physician practices.

Most recently, Lofgren served as senior vice president and chief clinical officer for the University Healthsystem Consortium (UHC) in Chicago. As a member of UHC's senior executive team, Lofgren was responsible for helping UHC members improve the quality, safety, efficiency and effectiveness of their clinical services as they transform their health care delivery systems. His responsibilities included health care delivery redesign, operational efficiencies, performance improvement and applied health services/quality research.

Before joining UKHC, Lofgren held various hospital, faculty and administrative posts throughout the Midwest, including the Medical College of Wisconsin, the University of Pittsburgh (and the Pittsburgh VA Medical Center); the University of Minnesota (and the Minneapolis VA Medical Center) and Michigan State University. He received his undergraduate degree from the University of Michigan, completed his residency and chief residency at the University of Minnesota and received a master of public health from the University of Minnesota School of Public Health. Lofgren, who is 59, is married to Lynn Lofgren. They have three grown daughters.

### **UCMC President's Corner**



Dear UC Medical Center Associates,

Since returning here in June, I have fully immersed myself in UC Health's five-year strategic plan, Plan 2017. While senior leadership is overseeing the progress of all 20 initiatives, we are spending a significant amount of our time focusing on Initiative #7, which is to "improve patient"

and family experiences at all service sites."

At UCMC we are doing a number of things to improve the patient and family experience.

One is adding a question to our Press Ganey survey asking patients if they were rounded on hourly. The intent of this is for our staff, whether it is a physician, nurse, therapist, PCA or environmental services, to check on our patients each hour and address any concerns or needs they may have. This may include asking questions such as "How are you feeling?" and "Is there anything I can do for you?"

The UCMC Patient and Family Centered Care Committee has taken another important step to improve the patient and family experience by reducing our more than 13 visitor policies into one policy, which includes allowing visitors to stay overnight with their loved one. This has significantly increased our patients' satisfaction. The committee is currently working on improving handoff of care at shift changes and how we can include the patient and their family in this interaction.

These are just two of many examples of projects that our staff is currently working on to increase our patients' satisfaction while at UCMC. You will continue to hear about new efforts being made throughout the hospital that provide our patients and families with a better overall experience. As you go about providing care for your patients I encourage you to put yourself in their shoes and see the experience through their eyes.

### **UC Health Implementing ICD-10**

If you haven't already heard, UC Health is implementing the ICD-10 Code Set. This transition is required for everyone covered by the Health Insurance Portability Accountability Act (HIPAA), including healthcare providers, payers, software vendors, clearinghouses and third party billing companies.

So, what exactly is ICD-10?

ICD-10 is the 10<sup>th</sup> revision of the International Statistical Classification of Diseases and Related Health Problems, a coding of diseases, signs and symptoms, abnormal findings, complaints, social circumstances and external causes of injury or diseases, as classified by the World Health Organization. The change to ICD-10 only affects diagnosis and inpatient procedure coding. CPT codes will continue to be reported for outpatient procedures and services.

The majority of associates and physicians will have to complete e-learning ICD-10 training starting in January 2014, as the deadline to implement these new code sets is **Oct. 1, 2014**. Please be on the lookout for more details and training information.

### **UC Health-Daniel Drake Center to Open New LTAC at Christ Hospital**

UC Health announced that on Nov. 25 Daniel Drake Center for Post-Acute Care opened a new, 30-bed, long-term acute care (LTAC) unit at The Christ Hospital in Mt. Auburn. **Daniel Drake Center at The Christ Hospital** will provide the same high level of care available at DDC's main campus for patients recovering from medically complex illnesses and injuries, including pulmonary and vent weaning. It is staffed similarly, with a multidisciplinary team of specialty trained professionals, including: physicians; nurses; respiratory therapists; physical, occupational and speech therapists; and dietitians. The unit is located on The Christ Hospital's third floor—3-West. Sunil Dama, MD, pulmonologist, will serve as medical director of the unit; Brenda Ziegler is administrative director; and Pat Adkins is director of clinical services.

"I would like to thank our partners at The Christ Hospital for their collaboration on this project, as well as the many UC Health employees who played a part in making this new venture a reality," said Nancy Barone, COO, UCMC and DDC. # Enroll Now. 2013 W-2 Forms Will Be Available Electronically

**Enroll by Jan. 12, 2014** to receive your electronic 2013 W-2 form online around Jan. 15, 2014. If you have previously enrolled W-2 online system, you do not have to re-enroll. This service offers many benefits, including:

- Secure, online access to your W-2
- W-2 is available immediately; no need to wait for a mailed copy
- Instantly obtain a W-2 reissue
- Download W-2 into tax preparation software (7 partners to choose from)
- Make correction (W-2c) requests
- Plus much more!

### How to log in:

  - o Enter your User ID which is your EIN
  - Enter your PIN:
    - If you have never logged into the system, you will need to enter your Default PIN which will be {the last 4 numbers of your SSN + your 4 year date of birth}. You will then be prompted to enroll in the Authentication program. This step is designed to ensure secure access to your W-2 information.
    - If you have previously enrolled and logged into the system but have forgotten your PIN, please click on the "Forgot my PIN" link and follow instructions on how to obtain your current PIN.

# Payroll Tax Increase in 2014

The Social Security Administration announced that the maximum amount of earnings subject to the Social Security payroll tax will increase to \$117,000 from \$113,700 beginning January 1, 2014.

The portion of the Social Security FICA that employees pay remains unchanged at the 6.2 percent withholding rate. Correspondingly, the portion of the



tax that employers pay also remains at 6.2 percent of employee wages. This amounts to a combined total Social Security FICA tax of 12.4 percent.

The Medicare portion of the FICA tax remains at 2.9 percent of which half, 1.45 percent is paid by employees and the other half by employers. Beginning in 2013, high earning employees paid in excess of \$200,000 in a calendar year became subject to a 0.9 percent Additional Medicare Tax for a total of 2.35 percent. The employer-paid portion of the Medicare tax on these amounts remains at 1.45 percent.

# New Chair, UC COM Dept. of Biomed. Informatics; UCMC Fellowship for Clinical Informatics

We are very happy to announce that Peter White, PhD, has accepted our offer to serve as Rieveschl Chair of the new Department of Biomedical Informatics at the College of Medicine and Director of the Division of Biomedical Informatics in the Department of Pediatrics and Cincinnati Children's Research Foundation. Dr. White currently serves as Director of the Center for Biomedical Informatics at the Children's Hospital of Philadelphia and is Research Associate Professor in the Department of Pediatrics at the University of Pennsylvania Perelman School of Medicine. His appointment in Cincinnati will be effective February 1, 2014, pending approval of the UC Board of Trustees. He will be functioning in this role two to three days each week before providing a full-time effort beginning July 1, 2014.

The overall mission of the Department of Biomedical Informatics is to use data to effectively create and apply knowledge to improve the understanding, diagnosis, treatment and prevention of health care issues. In this new role, Dr. White will develop vibrant and successful research and education programs in biomedical informatics that will build on previous work achieved here. The department will be the academic home for informatics faculty and will assist with collaborations and data sharing among our three institutions. The department was previously approved by the UC Board of Trustees.

Dr. White, who will have a secondary appointment as Professor of Pediatrics, will lead efforts to develop a collaborative service core to support institutional needs for both bioinformatics expertise and medical informatics research. Additionally, he will develop a medical fellowship program for clinical informatics at University of Cincinnati Medical Center, with the first fellow expected during the 2016 fiscal year, and a doctoral program in biomedical informatics, pending UC and Ohio Board of Regents approval.


