# Addendum: West Chester Hospital

In 2021 West Chester Hospital participated, as part of UC Health, in the collaborative development of a Regional Community Health Needs Assessment (CHNA) for Greater Cincinnati and Greater Dayton. This process, led by the Health Collaborative, incorporated considerable community input, including both community and provider surveys, focus groups, and stakeholder interviews. This addendum will be published with the CHNA Report in 2022. The addendum identifies significant regional health needs, and it also updates the status of the prior Implementation Plan.

West Chester Hospital has adopted the region's top priorities as identified in the Regional CHNA. In addition to the region's top priorities, West Chester Hospital included maternal/infant health as a CHNA priority due to its prevelance as an unmet health need in the population served by UC Health.

### **Prioritized CHNA Needs**

#### Priorities

The top priorities for the West Chester Hospital are:

- 1. Increase access to services in order to improve equitable outcomes for the region's top health care needs: behavioral health, cardiovascular disease, dental, vision and maternal/infant health.
- 2. Address access to and use of resources for food and housing, with a focus on the development and strengthening of partnerships between providers and community-based organizations.
- 3. Strengthen workforce pipeline and diversity, including cultural competence within the healthcare ecosystem.
